



Terms and conditions:

1.0 Information on how to enter the competition forms part of the conditions of entry. Entry into the promotion is deemed as acceptance of its terms and conditions.

1.1 The prize is for a maximum of two adults. It consists of:

 - c. The prizes are not transferable, refundable or exchangeable and cannot be redeemed for cash. You cannot change, vary, substitute or extend any element of the getaway (in whole or in part).
